

DECISION OF RTA MEETING HELD ON 29.01.2016 AT COLECTORATE CONFERENCE HALL

Item No. 1

In compliance of the direction from Hon'ble High Court of Kerala vide WPC No. 4579/2015, Thalassery Municipality recommended two places for the parking of auto taxi in Thalassery town. Request received from Secretary Thalassery Municipality for the approval of parking place recommended. Hence RTA **granted approval** for parking place for 5 each auto taxis in two places, ie one at near to Thalassery Treasury and another at near to vegetable market behind the Traffic Station, Thalassery.

Item No. 2

Heard Sri. P P Bharghavan counsel for the applicant and also the counsels for the objectors in detail. The application was to restrict the age of stage carriages for the issuance of fresh permit as within five years from the date of registration. Strong objection was raised against the restriction of age of stage carriages before this authority. Hence Secretary RTA is directed to furnish a detailed report regarding consequence of fixing the age as five years from registration and he is also directed to constitute a committee to study the matter and report the same before this authority. Hence **adjourned**.

Item No. 3

The Complainant or respondents are absent in the meeting. However it is ascertained from the file that the parking of contract carriages (Taxies) is unauthorised and inviolation of MV Act and Rules. This authority cannot allow such a parking. Hence the parking of the vehicles at road marking should be stopped. Secretary, RTA is directed to place the matter before the Traffic advisory Committee of Kannur Corporation and the directions of the traffic advisory committee shall place before this authority if necessary.

Item No. 4

The Applicant absent. Bus owners of that area objected the grant of bus stop stating that there are no students from this place and nearest bus stop are 100 mts limit from the proposed bus stop. More over there is a sharp curve abutting with the proposed bus stop and requested not to allow the same. Secretary RTA is directed to obtain a detailed report and place the matter before next RTA. Hence **adjourned**.

Item No.5

This is an application for grant of new bus stop for limited stop services at Ulippadi on the route portion Iritty-Kakkangad-Peravoor. Bus operators strongly object the grant of new limited stop bus stop at the proposed place. As per the report of the enquiry officer, nearest limited stop bus stop from the proposed stop is less than 1 km. Hence this authority does not find any reason to grant a new limited stop bus stop. Hence **rejected**.

Item No. 6.

This is an application for bus stop nr. Concord Arts and Science College, Muttannur. The enquiry officer reported that there is no necessity for the new bus stop as proposed. Hence **rejected**.

Item No. 7

Perused the judgement of Hon'ble High Court of Kerala vide WPc No. 23078/2015 dt. 04.09.2015. The item before this authority is to grant of concurrence for renewal of permit in respect of S/C KL 59/H 900 operating on the route Thalassery-Kasaragod (via) Kannur, Taliparamba, Payyannur, Karivellur, Mavungal as LSFP for the route portion Kalikadavu to Maheppalam which is within the jurisdiction of RTA Kannur. As per the notification GO (P) No. 73/2013/Trans dt. 16.7.2013 no renewal of permit can be granted as LSFP. Further Notification GO (MS) No. 45/2015/Trans dt. 20.08.2015 also not recommends the grant of renewal as LSFP. Hence the concurrence **rejected as LSFP**.

Item No. 8

Concurrence **granted** for renewal of permit in respect of S/C KL 13/T 2133 on the route Kannur – Kasaragod (via) Kanhangad, Payyannur, Taliparamba as LSOS for the portion lying in the jurisdiction of this RTA subjected to verification of scheme violation by the original authority.

Item No. 9

Concurrence **granted** for renewal of permit in respect of S/C KL 11/AE 2268 on the route Kuttikattoor-Kozhikode-Vadakara-Thalassery-Kannur as LSOS for the portion lying in the jurisdiction of this RTA subjected to verification of scheme violation by the original authority.

Item No. 10

Concurrence **granted** for renewal of permit in respect of S/C KL 58/D 4899 on the route Josgiri-Kanhangad (via) Pulingome, Cherupuzha, Peringome, Cheemeni, Cheruvathur as LSOS for the portion lying in the jurisdiction of this RTA subjected to verification of scheme violation by the original authority.

Item No. 11

Concurrence granted for renewal of permit in respect of S/C KL 12/G 3629 on the route Thalur-Parassinikadavu (via) Chulliode, Nidumpoil, Kuthuparamba, Thazhe Chovva, Kannur, Dharmasala as LSFP for the route portion lying within the jurisdiction of RTA, Kannur. As per the notification GO (P) No. 73/2013/Trans dt. 16.7.2013 no renewal of permit can be granted as LSFP. Further Notification GO (MS) No. 45/2015/Trans dt. 20.08.2015 also not recommends the grant the renewal as LSFP. Hence the concurrence rejected.

Item No. 12

The item before this authority is to consider the request for grant of concurrence for renewal of permit in respect of stage carriage S/C KL 34/A 7639, KL 34/B 596 (opposite services) conducting on the route Konnakkad-Pooppa (via) Vellarikundu, Chittarikkal, Cherupuzha, Udayagiri, Alakode, Taliparamba, Kannur, Thalassery, Mahe, Vadakara, Kozhikode, Valanchery, Kuttippuram, Edappal, Kunnamkulam, Guruvayoor, Kodungalloor, N Paravoor, Pathalam, Edappally, Ernakulam, Piravam, Koothattukulam, Ramapuram, Kollappally, Pala, Kattappana, Pambadumpara, Nedumkandam, Udumbanchola, as Super Express for the route portion lying within the jurisdiction of RTA, Kannur. As per the notification GO (P) No. 73/2013/Trans dt. 16.7.2013 no renewal of permit can be granted as LSFP. Further Notification GO (MS) No. 45/2015/Trans dt. 20.08.2015 also not recommends the grant the renewal as LSFP. Hence the concurrence **rejected**.

Item No. 13

Heard Sri P P Bharghavan counsel representing for the applicant Sri. Sudheer K for the grant of stage carriage permit on the route Mudappathur-Thalassery (via) Vattoli, Chittariparamba, Manantheri, Kuthuparamba, Kadirur and also perused the judgement of Hon'ble STAT, Ernakulam vide MVAA No.

171/2015 dt. 25.09.2015. Fresh regular permit **granted** as applied for subject to the settlement of timings. Further, the applicant is directed to produce a suitable vehicle within a period of one month, and on valid reasons, the said period of one month may be extended to another month only on application. If the applicant is failing to produce the records of suitable vehicle even in the extended period also the grant of permit stand revoked w.e.f. 29.03.2016.

Item No. 14

Heard Sri. E K Ramakrishnan counsel representing for the applicant Sri. Santhosh M for the grant of fresh regular permit on the route Parassinikadavu-Thirunelli Temple (via) Muyyam, Taliparamba, Sreekandapuram, Irikkur, Iritty, Peravoor, Kottiyoor, Mananthavady, Kottikulam as LSOS. RTA Wayanad concurred the grant of fresh regular permit in its meeting 4.5.2015. Fresh regular permit **granted** on the route applied for as ordinary mofussil service in respect of S/C KL 13/Q 2266 subject to the settlement of timings. There is no specific reason mentioned by the applicant to grant the permit as LSOS and there is no recommendation from the field officer to grant as LSOS. Limiting of stops would only results disadvantage to students and other communities on the isolated stopping places. Hence LSOS status cannot be allowed.

P P Abdul Latheef counsel representing for the applicant Ratheesh M for the grant of fresh regular permit on the route Cherukunnu Thara-Parassinikadavu-Mayyil-Sreekandapuram-Kannur HQ Hosp (via) Chinacle road, Dharmasala, Parassinikadavu, Kambil, Mullakody, Arimbra, Malappattam, Niranthode, Chekkikulam, Valiyannur, Munderimotta, Melechovva, Karinkalkuzhi, Cheruvathalamotta, Kaniyarvayal. Fresh regular permit **granted** subject to the settlement of timings.

Item No. 16

Heard Sri. Abdul Latheef counsel representing for the applicant Sri. Ayoob P P for the grant of fresh regular permit on the route Thottilpalam-Thalassery-Panoor (via) Kuttiadi, Nadapuram, Peringathur, Chokli, Manjodi, Koppalam, Manekkara. RTA Vadakara concurred the grant of fresh regular permit. Strong objection was raised by other operators of the sector stating that stage carriages are now conducting service on the route Nadapuram-Peringathur in every two minutes and there is no time slot for the issuance of a fresh regular permit. Hence fresh regular permit application **Rejected**

Item No. 17

Heard Sri. Abdul Latheef counsel representing for the applicant Sri. Jayesh V for the grant of fresh regular permit on the route Valayam-Thalassery-Thottummal (via) Kallachi, Nadapuram, Peringathur, Chokli, Manjodi, Kuyyali, Kolassery, Vadikkal. RTA Vadakara concurred the grant of fresh regular permit. Strong objection was raised by other operators of the sector stating that stage carriages are now conducting service on the route Nadapuram-Peringathur in every two minutes and there is no time slot for the issuance of a fresh regular permit. Hence fresh regular permit application **Rejected**

Heard Sri. E K Ramakrishnan counsel representing for the applicant Sri. P V Manoj Kumar for the grant of fresh regular permit on the route Taliparamba-Chemperai Engg College-Mayyil (via) Valakkai, Chepparamba, Chempanthotty, Sreekandapuram, Chengalayi, Vadakkanchery, Parassinikadavu, Mullakody, Malapattam, Kaniyar vayal. Fresh regular permit **granted** as applied for in respect of S/C KL 59/M 2016 subject to the settlement of timing.

Item No. 19

Heard Smt. Domittilla Sequeira counsel representing for the applicant Sri. Shahil A for the grant of fresh regular permit on the route Naduvil-Kannadippara-Taliparamba-Muthussery (via) Thazhe Vilakkannur, Padappengad, Someswary Temple, Chimminichootta, Nadukani, Oduvally, Karuvanchal, Karthikapuram, Udayagiri, Thalippara. The vehicle shown in the application S/C KL 59/A 3488 is operating on another route with a regular permit valid upto 24.4.2017. The grant of a new regular permit to this vehicle lead to the withdrawal of an existing route permit which would cause inconvenience for the passengers on that route. The applicant today assured to produce the RC of a later model vehicle within 30 days from today. However the permit is **granted** as applied for subject to the settlement of timings.

The grantee is directed to produce the RC of later model suitable stage carriage and current records of vehicle if any possessed by him. Where the applicant is failing to produce the said documents within the period of one month, on valid reasons, the said period of one month may be extended to another one month only on application. In case if the applicant is failing to produce the records even on extended period also the grant of permit stand revoked, w.e.f 29.03.16

Shuhaib N N for the grant of fresh regular permit on the route Vayathur Temple-Kannur-Sreekandapuram (via) Ulikkal, Iritty, Mattannur, Chalode, Melechovva, Kololam, Irikkur, Mannurpalam, Maruthayi. A fresh regular permit is **granted** in respect of S/C KL 58/R 5763 as applied for subject to the settlement of timings.

Heard Sri. P P Bharghavan counsel representing for the applicant Sri. Beshi Mathew for the grant of fresh regular permit on the route Santhigiri-Chandanakampara-Kottiyoor (via) Vendekumchal, Poyannmala, Kelakam, Thondiyil, Peravoor, Iritty, Ulikkal, Payyavoor. A fresh regular permit is **granted** in respect of S/C KL 13/K 4969 as applied for subject to the settlement of timings.

Item No. 22

Heard Sri P P Bharghavan counsel representing for the applicant Sri. P V Vinod Kumar for the grant of fresh regular permit on the route Thalassery-Nadapuram (via) Manjodi, Chokli, Peringathur, Thuneri. Strong objection was raised by the other operators from the sector stating that presently stage carriage are conducting service on the route portion Nadapuram-Peringathur in every two minute. It is very difficult to find a time slot for the issuance of a fresh regular permit. The objection raised before this authority is not legally sustainable and this authority did not feel that the objection raised by other operators is a ground to reject the application. Hence fresh regular permit **granted** in respect of S/C KL 58/Q 8595 subject to the settlement of timings.

Heard Sri. P P Bharghavan, counsel representing for the applicant Sri. Balamohanababu for the grant of fresh regular permit on the route Panoor-Thalassery-Mananthavady-Valad-Kannur (via) Kuthuparamba, Nidumpoil, Chandanathode, Thalappuzha, Mambaram, Chala, Manjodi, Koppalam, Champad as LSOS. As per the report of the enquiry officer, out of the total route length, 36 kilometers lies within the jurisdiction of RTA, Wayanad. Hence Secretary, RTA is directed to call concurrence from RTA Wayanad for the route portion lying within the jurisdiction of RTA Wayanad. Hence **adjourned**.

Heard Sri. P P Abdul Latheef counsel representing for the applicant Sri. Sunil Kumar K V for the grant of fresh regular permit on the route Koorara-Kuthuparamba-Thalassery (via) Kakkara, Chonadam,

Kunduchira, Kadirur, Kottayodi, Kongatta, Brammanmukku, Therppankottam Temple, Chundangapoi, Ponniam Palam, Mele Chempad, Koppalam, Manjodi. The vehicle shown in the application S/C KL 58/H 8580 is now conducting service on the route Parammal School-Thalassery which is valid upto 19.10.2017. Grant of new regular permit to the same vehicle on another route means the withdrawal of permit from the existing route which will surely adversely affect the travelling public from that area. The applicant assured before this authority that he will produce the records of later model vehicle within a period of one month. However fresh regular permit **granted** subject to the settlement of timings.

The grantee is directed to produce the RC of later model suitable stage carriage and current records of vehicle if any possessed by him, within one month from today. Where the applicant is unable to produce the current records within a period of one month, on valid reasons, the said period may be extended to one more month only on application. In case if the applicant failed to produce the records even within the extended period also, the grant of permit stand revoked w.e.f 29.03.2016.

However fresh regular permit **granted** subject to the settlement of timings with a direction to produce the vehicle within one month.

The grantee is directed to produce the RC of later model suitable stage carriage and current records of vehicle if any possessed by him, within one month from today. Where the applicant is unable to produce the current records within a period of one month, on valid reasons, the said period may be extended to one more month only on application. In case if the applicant is failing to produce the records even within the extended period also, the grant of permit stand revoked w.e.f. 29.03.2016.

Where the applicant is unable to produce the current records within a period of one month, on valid reasons, the said period may be extended to one more month only on application. In case if the applicant is failing to produce the records even within the extended period also, the grant of permit stand revoked w.e.f 29.03.2016.

Where the applicant is unable to produce the current records within a period of one month, on valid reasons, the said period may be extended to one more month only on application. In case if the applicant is failing to produce the records within the extended period also, the grant of permit stand revoked w.e.f. 29.03.2016..

Objection raised by other operators from the same route that on the proposed route portion Nadapuram-Thalassery stage carriage is now conducting service in every two minute, so it is not possible to find a time slot on that route portion. The objection raised by the other operators is not legally sustainable. This authority did not find the condition raised by the operators is a reason to reject the application. Hence a fresh regular permit **granted** for a later model suitable vehicle as applied subject to the settlement of timings.

The grantee is directed to produce the RC of later model suitable stage carriage and current records of vehicle if any possessed by him within one month from today. Where the applicant is unable to produce the current records within a period of one month, on valid reasons, the said period may be extended to one more month only on application. In case if the applicant is failing to produce the records even within the extended period also the grant of permit stand revoked w.e.f 29.03.2016.

It is now found that various buses are not exhibiting the number in the destination board. Hence RTA is directed to Secretary RTA to take steps to exhibit the number in the destination board itself with following specification.

- (a) The number allotted to the buses should be exhibited in the left side of the destination board in a diameter of 25cm width round.
- (b) The buses starting from Thavakkara bus stand shall exhibit the number in black letters in yellow colored board.
- (c) The buses starting from Kannur HQ bus stand shall exhibit the number in black letters in red colored board.

RTA also felt that the procrastination of route to 115 kms proceeding only single trip from Peravoor to Chekkikulam the major focused part of the route is

only to defeat the Notification No. GO No. 42/2009. KSRTC objected the grant. The applicant failed to produce suitable stage carriage before this authority even at the time of hearing in RTA. Hence the application **rejected**.
