GENERAL MATTERS

Item No 1.

Ref No G/8939/2016/C

This is an application for sanction of new bus stop in front of Rayarome Govt school. Heard and **granted** subject to the condition that the bus stop shall be provided in between the school and Pallippady bus stop after the curved portion of the road; and the bus stops on opposite sides should be 50 meters apart.
