WHERE AS, it appears to the Kerala that the land specified in the schedule below is needed or likely to be needed for a public purpose, to wit for acquisition of land for the construction of temporary storm water drainage at Kannur airport.

AND WHEREAS, in exercise of the powers conferred in sub section(1) of section 4 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), Government of Kerala have authorised District Collector as appropriate Government for an extent of land not exceeding 200 Ares in a district for the public purpose as per GO.(P) No.376/2016/RD dated 29-06-2016 and SRO No.468/16, and have decided to conduct a Social Impact Assessment in the area specified in the schedule below.

Now, THEREFORE, sanction is accorded to the VIJIL MATTANNUR, KANNUR District to conduct a Social Impact assessment study and to prepare a Social Impact Management plan as provided in the Act. The process shall be completed within a period of one months, not exceeding six months in any case.
