As per the ref.first cited P.V Raveendran , Kannapuram PO-Cherukunnu has filed an application in Form-4 under Kerala Conservation of Paddy Land & Wet Land Act-08(28 of 2008 (G.O (P)611/2015/RD Dt.17 /11/2015 for regularisation of 27.60 ares of land comprised in R.S 338/1 Kannapuram Amsam Desam in Kannur Taluk after paying an amount of Rs.500/- towards the application fee as insisted in the G.O reffered above.

As per the ref. second cited report on application in Form-5 was filed by Village Officer Kannapuram. As per the report land in question i.e 27.60 ares of land comprised in R.S 338/1 in Kannapuram Amsam desam was converted prior to 12/8/2008 and has recommended to grant regularization of 27.60Ares.Incontinuation hearing in this case was conducted on 29/06/2016 @ 3 p.m both Village Officer,Kannapuram and the applicant were present.The Village Officer stated that there are coconut trees and arecanut trees of more than15 years and no paddy cultivation is in this plot .The photo produced prove the same and ordered to grant permission for regularisation for 12.14 ares.

Accordingly Form-6 notice of the said Act was issued for remitting an amount of Rs.50,078/-(Fifty Thousand and Seventy Eight rupees Only)being the fee for regularization of 30 cents.The original chalan No.371 Dt.14/7 /2016 District Treasury Office,Kannur regarding the payment of Rs.50,078/-(Fifty Thousand and Seventy Eight rupees Only) in favour of applicant was submitted in this office. In this context, permission for regularization of 30cents of land comprised in R.S 338/1 Kananpuram amsam desam in Kannur Taluk is hereby granted as per G.O.(P)611/2015 Dt.17 /11/2015 Kerala Conservation of Paddy Land and Wet Land (Regularisation of Unauthorised Reclamation) Rules 2015
