As per the ref.first cited Rukhiya V.A, V.A House (PO)  
Irinavu has filed an application in Form-4 under Kerala  
Conservation of Paddy Land & Wet Land  
Act-08(28 of 2008 (G.O (P)611/2015/RD Dt.17 /11/2015 for  
regularisation of 13 cents of land comprised in R.S 97/3  
Kalliassery Amsam Desam in Kannur Taluk after paying an  
amount of Rs.500/- towards the application fee as insisted in  
the G.O reffered above.

As per the ref. second cited report on application in  
Form-5 was filed by Village Officer kalliassery.As per the  
report land in question i.e 13 cents of land comprised in R.S  
97/3 in Kalliassery Amsam Irinav desam was converted prior  
to 12/8/2008 and has recommended to grant regularization  
after collecting an amount of Rs.39,450/-(Rupees Thirty Nine  
Thousand Four Hundred and Fifty Only )i.e 25% of fairvalue  
fixed for the land in question.In continuation hearing in this  
case was conducted on 08/06/2016 @ 3 p.m both Village  
Officer,Kalliassery and the applicant were present. The land is  
not in databank. The photos show that there are coconut trees  
of 15 years old and this land has no paddy cultivation. There

are Houses nearby.

Accordingly Form-6 of the said Act was issued for remitting an amount of Rs.39,450/-(Rupees Thirty Nine Thousand Four Hundred and Fifty Only )

being the fee for regularization recommended by the Village Officer.The original

chalan.No.522 Dt.27/6/2016 District Treasury Office,kannur regarding the payment of 39,450/-(Rupees Thirty Nine Thousand Four Hundred and Fifty Only ) in favour of applicant was submitted in this office .In this context, permission for regularization of 13 cents of land comprised in R.S 97/3 in Kalliyassery amsam Irinavu desam in Kannur Taluk is hereby granted as per G.O.(P)611/2015 Dt.17 /11/2015 Kerala Conservation of Paddy Land and Wet Land (Regularisation of Unauthorised Reclamation) Rules 2015
